Civic Works Baltimore City \$350,000

Civic Works, Baltimore's Service Corps and an AmeriCorps organization, was founded in 1993 to strengthen Baltimore's communities through education, workforce skills development and community service. Civic Works aims to provide energy audits to approximately 100 homes and whole house improvements to at least 41 Baltimore City homes. Half the homes will receive only LED lightbulbs, lowflow showerheads, and faucet aerators. The remaining homes will receive these retrofits as well as air sealing and insulation under the Whole Home/Whole Building upgrades model.

Diversified Housing Development (DHD) Baltimore City \$100,000

DHD is a nonprofit founded in 2002 to promote affordable housing options for low and moderateincome families. DHD will complete Whole Home/Whole Building upgrades consisting of performing energy audits on the home or buildings and then installing the most cost-effective energy efficiency and weatherization measures to at least 20 low to moderate income households.

Green and Healthy Homes Initiative's (GHHI) **Baltimore City** \$286,565

GHHI's mission is to break the link between unhealthy housing and unhealthy families by creating and advocating for healthy, safe, and energy efficient homes. GHHI will use funding from MEA to conduct energy audits and install cost-effective energy efficiency measures based on audit findings in at least 34 homes.

Healthy Neighborhoods, Inc. (HNI) **Baltimore City** \$350,000

Healthy Neighborhoods maintains and improves neighborhoods by supporting block projects that improve and enhance physical assets and neighborhood amenities, increasing property value, and building neighborhood confidence. HNI will use funding from MEA to complete cost-effective energy efficiency measures to up to 15 buildings non-residential building located in Baltimore City which predominantly benefit LMI Marylanders.

BlockChain Frontiers Foundation, Inc. (BFF) **Central Region** \$500,000

BlockChain Frontiers Foundation, Inc. is a non-profit foundation located in Prince George's County, Maryland. Their mission is to work with communities developing sustainable principles, policies, and community programs which seek to enhance citizen health and housing programs and/or reduce the cost of living. BFF will use funding from MEA to conduct energy audits and install cost-effective energy efficiency measures based on audit findings in at least 59 homes located in Baltimore, Carroll, Cecil, Harford, Howard, and Montgomery Counties.

Civic Works, Inc. \$400,000 **Central Region**

Civic Works, Baltimore's Service Corps and an AmeriCorps organization, was founded in 1993 to strengthen Baltimore's communities through education, skills development and community service. Civic Works will use funding from MEA to conduct energy audits and install cost-effective energy efficiency measures based on audit findings in at least 47 homes located in Baltimore, Carroll, Cecil, Harford, Howard, and Montgomery Counties.



Community Action Council of Howard County, Inc. Central Region

\$183,156

CAC of Howard County is a not for profit community action agency that manages many grants and programs that benefit low-income residents. With MEA funds, CAC of Howard County will be continuing work on Ivy Crossing Apartments, in Catonsville, a housing project previously started in last year's (FY19) cycle. Cost-effective measures include floor insulation, R6 pipe insulation, light bulbs, and air sealing in at least 94 homes_located in Baltimore County.

Community Action Council of Howard County, Inc. Central Region

\$87,000

CAC of Howard County is a not for profit community action agency that manages many grants and programs that benefit low-income residents. With MEA funds, CAC of Howard County will use funding from MEA to conduct energy audits and install cost-effective energy efficiency measures based on audit findings in at least 10 single-family homes located in Howard County.

Habitat for Humanity Susquehanna, Inc.

Habitat for Humanity Susquehanna creates affordable housing opportunities throughout Harford and Cecil Counties by building, renovating and repairing homes in partnerships with the community. With MEA funding, Habitat for Humanity Susquehanna will implement energy retrofits in 25 homes and fund the incremental costs of energy efficiency measures installed in approximately 7 to-be-constructed homes for low-income Maryland residents.

SAFE Housing, Inc.

Central Region

\$388,553

SAFE Housing works to help economically disadvantaged people obtain or create safe, energy efficient housing. SAFE Housing will implement Whole Home/Whole Building upgrades to achieve a 10-year payback on installed measures. SAFE Housing will also service households that have been deferred due to health and safety concerns. With MEA funding, SAFE Housing will conduct energy audits and install cost-effective energy efficiency measures to at least 46 homes in Carroll, Cecil, and Harford Counties.



Choptank Electric Cooperative

Eastern Region

\$154,843

Choptank Electric Cooperative is a member-owned electric distribution utility that serves over 52,406 residential, commercial and industrial accounts in parts of all nine counties of Maryland's Eastern Shore. With MEA funding, Choptank Electric will perform Whole Home/Whole Building upgrades that will include energy audits and installation of the most cost-effective energy efficiency and weatherization measures in at least 18 homes.

Habitat for Humanity Choptank

Eastern Region

\$100,000

Habitat for Humanity Choptank empowers low-income households to improve their housing conditions. Habitat for Humanity Choptank has grown in capacity from Talbot and Dorchester counties and has also diversified its projects beyond single-family new construction to include rehabs as well as new construction multi-family builds. Habitat for Humanity Choptank will implement energy retrofits in at least_12 homes and fund the incremental costs of energy efficiency measures installed in approximately 8 to-be-constructed homes for low income Maryland residents.

SAFE Housing, Inc.

Eastern Region

\$200,000

SAFE Housing works to help economically disadvantaged people obtain or create safe, energy efficient housing. SAFE Housing will implement Whole Home/Whole Building upgrades to achieve a 10-year payback on installed measures. SAFE Housing will also service households that have been deferred due to health and safety concerns. With MEA funding, SAFE Housing will conduct energy audits and install cost-effective energy efficiency measures to at least 24 homes in Dorchester, Somerset, Wicomico, and Worcester Counties.

Wicomico County Housing Authority

Eastern Region

Wicomico County Housing Authority provides services of affordable housing operations for income based families. With MEA funding, Wicomico County Housing Authority will use the Whole Home/Whole Building approach to perform energy audits and install cost-effective energy efficiency and weatherization measures to at least 9 housing units to assist with bringing vacant units back into stock, thereby increasing housing opportunities for Wicomico residents - while keeping them affordable.

Arundel Community Development Services (ACDS) Southern Region

ACDS is a private, nonprofit corporation established by Anne Arundel County to create and retain affordable housing opportunities within the County, and to ensure the efficient delivery of community development services to those most in need. ACDS will upgrade at least 70 households in the Robinwood community using Whole Home/Whole Building upgrades that will consist of performing energy audits on the home or building and then installing the most cost-effective energy efficiency and weatherization measures.

CAC of Howard County is a not for profit community action agency that manages many grants and programs that benefit low-income residents. With MEA funds, CAC of Howard County will perform cost-effective air sealing, HVAC, and weatherization upgrades. Measures include attic insulation, water heater pipe insulation, light bulbs, replacement of old Packaged Terminal Air Conditioner systems with ductless min-split systems, and air sealing in at least 24 homes_located in Anne Arundel County.

Habitat for Humanity Metro Maryland (HFHMM) Southern Region

\$52,610

HFHMM strives to provide a sustainable solution to the housing crisis affecting Montgomery and Prince George's Counties. Habitat for Humanity Metro Maryland will conduct energy audits and then weatherize and make other energy efficiency improvements to at least 6 low-to-moderate income homes.

Housing Authority of St. Mary's County (HASMC) Southern Region

\$100,000

HASMC aims to improve communities through beneficial services and programs and preserve affordable homeownership and rental housing for all citizens in need. HASMC will use funding from MEA to conduct energy audits and install energy efficiency measures based on audit findings in at least 12 homes in Calvert, Charles, and St. Mary's Counties.

SAFE Housing, Inc.

\$150,087

SAFE Housing works to help economically disadvantaged people obtain or create safe, energy-efficient housing. SAFE Housing will implement Whole Home/Whole Building upgrades to achieve a 10-year payback on installed measures. SAFE Housing will also service households that have been deferred due to health and safety concerns. With MEA funding, SAFE Housing will conduct energy audits and install cost-effective energy efficiency measures to at least 18 homes in Calvert, Charles, and St. Mary's Counties.

Town of North Beach

Home Performance projects require an energy audit, which is followed by the installation of measures recommended by the audit.

Frederick County Office of Sustainability and Environmental Resources (OSER) advances practical solutions for protecting the environment, conserving energy, and sustainable living. Using MEA funds, Frederick County will conduct energy audits and install cost-effective energy efficiency upgrades to at least 18 homes via the Whole Home/Whole Building approach. They will also provide education on both energy efficiency measures and energy conservation behaviors that together can maximize electricity and fuel reductions and cost savings.

SAFE Housing, Inc. Western Region \$330,417

SAFE Housing works to help economically disadvantaged people obtain or create safe, energy efficient housing. SAFE Housing will implement Whole Home/Whole Building upgrades to achieve a 10-year payback on installed measures. SAFE Housing will also service households that have been deferred due to health and safety concerns. With MEA funding, SAFE Housing will conduct energy audits and install cost-effective energy efficiency measures to at least 39 homes in Allegany and Garrett Counties.

Washington County Housing Solutions Western Region \$80,000

Washington County Housing Solutions aims to support clients and programs of the Housing Authority of Washington County through advocacy, community outreach, and fund development. With MEA funding, Washington County Housing Solutions will perform an energy audit and then install the most cost-effective energy efficiency and weatherization measures in at least 9 homes in Tanglewood Court in Washington County.
