 - Identifies whether the MSAP rebate will be paid to the homeowner or paid to the MSAP Participating Contractor. If applicable, provides authorization for the State of Maryland to disburse the rebate payment to the MSAP Participating Contractor.
4. **Section 4: Acknowledgements:** The homeowner, the MSAP Participating Contractor, and the MSAP Authorized Seller (if different from the MSAP Participating Contractor) each acknowledge they have reviewed and understand the MSAP Authorizations & Disclosures Form, the terms of the solar PV agreement, consumer rights,

responsibilities, and financial obligations related to the solar PV system. The MSAP Participating Contractor acknowledges responsibility for compliance with the terms and conditions of the Program, including the Fossil Fuel Policy, and all applicable local, state, and federal laws, regulations, and building codes.
